Transparency notification by Artisan Partners Limited Partnership and Artisan Partners Asset Management Inc.

1. Summary of the notification

In accordance with article 14 § 1 of the law of May 2, 2007 on disclosure of major shareholdings, Groupe Bruxelles Lambert ("GBL") has received a transparency notification dated April 27, 2023 indicating that as of April 24, 2023 Artisan Partners Limited Partnership and Artisan Partners Asset Management Inc. held 5.00% of GBL's voting rights.

2. Content of the notification

Under a contractual proxy, APLP exercises voting rights in GBL on a discretionary basis for a number of clients, of which no client individually holds shares representing 5% or more of the voting rights in GBL. The form displays 5% of the voting rights in section 10), while the actual percentage is 4.997%. This is due to the rounding of the form.
